### Terms and Conditions of the Exhibition

1. The Exhibitor will be solely responsible for the quality and quantity of the commodities, goods and items exhibited and sold in the Exhibition.
2. It will be the responsibility of the Exhibitor to comply with all the prevailing taxation rules and other relevant laws, rules and regulations of the local, State and Country Governments.
3. The Organizer reserves the right to alter or modify the layout, size, number and location of the Exhibition Stalls without informing the Exhibitor.
4. The exhibition space is limited to the Shell space, including the facilities for the relevant stall category. Any additional facilities, if required, will be provided to the Exhibitor subject to availability and will be charged extra. Intimation regarding additional requirements should be submitted to the Organizer in writing two months before the events.
5. Visa application and interview preparation charges are non refundable in any case. In case of visa refusal, the booking amount towards participation charges will be refunded to the Exhibitor after deducting visa processing charges.
6. Only two people can apply from one participating company. A maximum of two invitation letters will be issued to a single participating company.
7. In case of refusal of visa to one of the two visa applicants from the participating company, the applicant whose visa is granted is expected to travel alone and participate at the event. Cancellation of stall booking will not be accepted and refund of stall booking amount will not be made in such case.
8. For the Exhibitor holding valid US visa, participation charges will not be refunded for any reasons whatsoever including denial of entry to the US by the US authority. The Exhibitor, in such case, will need to depute another representative with valid US visa for participation in the event.
9. In the event of the exhibition being cancelled because of unforeseen circumstances, the Organizer will return the amount paid by the Exhibitor without interest.
10. Exhibitor will restrict their display, banner, standee, mannequins table, chair etc within the allotted area only. If the Exhibitor encroaches the space other than the allotted area, the Organizer reserves the right to cancel their booking and forfeit the amount.
11. The Exhibitor shall display the same company / product name at the stall as is mentioned in the said registration form. Failure to do so shall lead to cancellation of the booking and forfeiture of the amount.

**Insurance:** All ascertainable risks from transportation to display and removal should be insured by the exhibitors at their cost. Participants will insure their exhibits against loss, damage, theft, fire or any cause whatsoever. They will also ensure third party insurance cover for the total duration. Third party insurance, accidental insurance of exhibitor's personnel, damage insurance etc. will be the responsibility of the exhibitors.

**Force Majeure:** If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, natural calamity, national emergency, election, labour dispute, riots, strike, the non-availability ground or any other cause not within the control of the organiser, the Organizer reserves the right to change the opening dates and duration or even cancellation of the entire exhibition. In case of such condition the Organizer may at their entire discretion, repay the rental paid by the exhibitor or part there of after deduction of the proportionate costs already incurred by the Organizer and shall be under no liability in respect to any actions, claims or losses.

Disputes, if any, will be subject to Ahmedabad jurisdiction.
